Mr. Hendrickson talked about the FirstLink Annual Breakfast he attended; the speaker was Dennis Gillan who is a professional mental health advocate. Council Member Hendrickson shared that he attended the Fargo-Moorhead Area Music Club Luncheon and read a proclamation for National Music Week at the event.

Mayor Shelly Carlson provided council with a Fargo Moorhead Diversion Project and funding update.
